- Must have an EASA Part 66 License in category B1 and / or B2 endorsed with applicable Aircraft Type Rating
- Able to speak, read and write fluent English.
- Possess strong technical judgement and trouble-shooting skills.
- Possess excellent problem solving, analytical and decision-making skills.
- Have a proven ability to work well under pressure and work to pressurized deadlines.
